Importing a Vehicle into Canada

Importing a Motor Vehicle into Canada can be a complicated process. You have to make sure you do your homework before you undertake such a venture. It can be a rewarding venture but be careful. If done incorrectly, it can cost you much more than anticipated or at worst you may have purchased a vehicle but cannot import it into Canada.

Here's a synopsis of government agencies involved and the main requirements :

Canada Border Services Agency (CBSA)

For vehicles imported from and registered in the U.S. there is no age restriction. For vehicles being imported from all other countries, in general, they need to be 15 years old or older based on the date of manufacture.

The CBSA imposes duties and collects taxes on behalf of other government departments. In general here is a list of fees to be expected at time or after import;

- Duty: 6.1% (some vehicles may be duty free from the USA/Mexico
- Gst : 5%
- Excise tax for Air conditioning: \$100.00
- Green Levy
- PST at various rates based on province of registration (7% in B.C.) payable at time vehicle is insured
- The Registrar of Imported Vehicles imposes a \$192.00 fee on vehicles from the USA less than 15 years old
- CFIA inspection fee: \$43.00 applicable to vehicles imported from a country other than the USA. Steam Cleaning fees may apply if it has not been sufficiently cleaned.

Transport Canada

Vehicles less than 15 years old from the U.S. are highly regulated by Transport Canada. The Registrar of Imported Vehicles (RIV) administer and enforce many of these rules. When you have chosen a make and model of vehicle, the first thing you must do is to check with the RIV to ensure that it is on the list of admissible vehicles. The registrar can also tell you what specific modifications will need to be made to your vehicle after import. Their contact information is: Phone: 1-888-848-8240 or www.riv.ca. The RIV will also require a recall letter (http://www.riv.ca/english/html/recall_clearance.html).

US Customs

Any self propelled vehicle coming from the US must be reported to US Customs 72 hours prior to export from the US. This also includes vehicles that are not licensed for the road. Failure to do so will result in a \$400.00 USD fine by US Customs. The vehicle must also stop at US Customs before it physically crosses into Canada. The contact information is as follows:

Canadian Food Inspection Agency (CFIA)

Soil and related matter can carry pests harmful to Canadian agriculture. The Canadian Food Inspection Agency (CFIA) requires that you wash any sand, soil, earth, and plant residue from your passenger and recreational vehicles, Including the undercarriage, before you import them. This requirement does not apply to vehicles entering Canada from the continental United States.

Excise Tax (Green Levy) on fuel inefficient cars

This tax is applicable to vehicles purchased in Canada or imported from the US and is applied to a passenger vehicle if it:

- is a car, SUV or VAN with a weighted average fuel consumption of 13 litres per 100 km or higher, and
- was put into service after March 19, 2007.

Vehicles are taxed, based on weighted average fuel consumption, at the followings rates:

- At least 13, but less than 14 litres per 100 km: \$1.000
- At least 14, but less than 15 litres per 100 km :\$2.000
- At least 15, but less than 16 litres per 100km: \$3.000
- 16 or more litres per 100 km: \$ 4.000
